Instructions on Ph.D. Course Work (2021)

1. As per the Regulation 10 (i) of the Maharashtra National Law University, Nagpur Ph.D. (Doctor of Philosophy) Regulations 2017 the Ph.D. course work shall be of **22 credits** in total divided in Seven (07) Courses including the course titled "Research and Publication Ethics (RPE)" as per the University Grants Commission 543rd Meeting Resolution held on August 9th, 2019 (Vide Letter No. F. I.-1/2018 (Journal CARE) dated December, 2019). However, for external Research Scholars only following courses will be offered:

2. No Registration fee for attending the Ph.D. course work;
3. The classes will be conducted online using Cisco WebEx Portal;
4. The total duration of the course work shall be split into three clusters, spread over the entire Semester period;
5. Convenor, Doctoral Council shall coordinate the Ph.D. course work including class schedule and liaising with subject experts;
6. The candidates who are regular in attendance and does not take part in course work Examination will get the Participation Certificate from the University;
7. The candidates who are regular in attendance, appeared and passed the course work Examination will get the Course Work Completion Certificate from the University; and
8. The University reserves the right to expel any candidate at any point of time during the period of course work, if the candidate's involvement is not satisfactory.
