It will also assess awareness and satisfaction regarding the SSY scheme in these regions. The research will involve the development of tools to measure the scheme's performance, in-depth interviews with experts, pilot studies, and data collection. Furthermore, the project will investigate the scheme's influence on financial inclusion and its social impact.
