ENTRANCE TEST FOR ONE-YEAR LL.M. (POSTGRADUATE) DEGREE COURSE FOR EXECUTIVES

- ➤ The Entrance Test shall be in Physical (Pen and Paper) Mode.
- ➤ The Entrance Test shall be of ninety (90) minutes comprising hundred (100) Multiple-Choice Questions (MCQs) carrying one (1) mark each. There shall be negative marking of 0.25 marks for every wrong answer.
- The Entrance Test is scheduled on November 5, 2023, (Sunday) from 10:30 AM to 12:00 PM.
- ➤ The Entrance Test shall be conducted in English Language.
- ➤ Venue of Examination is Maharashtra National Law University, Near Village Waranga, PO: Dongargaon (Butibori), Nagpur 441108 Maharashtra, India.

Syllabus and Marking Scheme

English: This section will consist of questions on the areas like Vocabulary (Synonyms, Antonyms, analogies etc.) Proficiency (Idioms and Phrases, One-word Substitution, Sentence Improvement, and rearrangement, Fill in the Blanks etc.) English Usage Errors (Common errors, spotting errors, inappropriate usage of words, spelling mistakes etc.).

General Knowledge with Current Affairs: The topics such as History, Geography, General Science, Economics, Civics, and Current Affairs. This section is to assess the knowledge of the recent happening and awareness of the World.

Legal Aptitude and Legal Reasoning: This section will test candidate's interest towards the study of Law, Legal Aptitude, and problem-solving ability.

General Instructions:

- Candidates are advised to visit the venue one day before the Entrance Test to confirm the location to ensure timely reporting on the day of the examination.
- ➤ For detailed information regarding the intake, reservation policy, fee, subjects offered, etc., the candidates may refer to the information available at the e-brochure and/or websites of the University.
- The registration for Entrance Test shall close on October 31, 2023.
- ➤ The application form, complete in all respects and after payment of fee must be submitted using the registration link on or before October 31, 2023 (11:59 P.M.).

- Incomplete application form shall not be considered. The candidates shall fill and submit the application form well in time to avoid last minute inconvenience.
- > The University shall in no case be responsible for any incomplete information or misinformation or inconvenience faced by the candidate in this regard.
- ➤ Please fill the form carefully. The Name of the candidate and the parents shall be spelt correctly in the application as it appears in the Certificates/Mark sheets/Identity proof. Any change/alteration found may disqualify the candidature.
- ➤ In order to claim the benefit of reservation, the candidate must produce the relevant certificates as prescribed by the Government of India/State Government and as required by the University at the time of admission.
- ➤ The application fee is non-refundable and non-negotiable.
- ➤ If a candidate has filled-in more than one online application form, the candidate's last online application form only shall be considered. In such cases, the application fee for the previous application forms shall be refunded on demand.

Guidelines for Persons with Disabilities using a Scribe:

- The candidate shall have to arrange his/her own scribe at his/her own cost.
- The person acting as a Scribe for one candidate cannot be a Scribe for another candidate.
- > the candidate as well as the scribe, shall have to give a suitable undertaking confirming that the scribe fulfils all the stipulated eligibility criteria for a scribe.
- The Scribe can be from any Academic discipline.
- > The Scribe arranged by the candidate should not be a candidate for the same examination.
- ➤ The candidate who uses a Scribe shall be eligible for Compensatory Time of 20 minutes for every hour of the examination.
