Instructions for Candidates

This is to inform the candidates who have been shortlisted for the B.A.LL.B. (Hons. in Adjudication and Justicing) Course for the Batch of 2025-30. The instructions below must be followed to confirm your admission.

Payment of Fees

To secure your provisional admission, you must complete the payment of the First-Year fees for the Academic Year 2025-26 by **September 8, 2025**, The total fee is **₹3,85,000/-**. You can pay using one of the two methods below:

1. SBI Collect:

2. Demand Draft:

- Selected candidates must bring a Demand Draft of **₹3,85,000/- (Three Lakh Eighty-Five Thousand Rupees only)**.
- The Demand Draft should be made in favour of "**Registrar, Maharashtra National Law University, Nagpur,**" payable at Nagpur.

Payment Confirmation and Receipts

Candidates who will make the payment using SBI Collect link are required to carry the proof of payment while reporting to university and must email the payment receipt to both accounts@nlunagpur.ac.in and admission@nlunagpur.ac.in. Please note that payment confirmation will be made after 48 hours. If you make payments in multiple parts, please merge all receipts into a single file (preferably a PDF) before emailing. You must also carry a physical copy of the payment proof with you.
