Participation in the registration process shall not confer any right to admission. Admission shall be subject to merit, category-wise seat availability, fulfilment of eligibility conditions, document verification and payment of the prescribed fees within the stipulated time.

Important Instructions:

1. Candidates who have qualified **CLAT-2026** and fulfil the prescribed eligibility requirements may register for the Spot Admission Round.
2. Candidates shall be solely responsible for ensuring their eligibility before submitting the registration form.
3. Candidates must carefully select the programme for which they wish to participate in the Spot Admission Round.
4. Candidates shall complete the online registration within the specified period and provide all required information and upload or submit the prescribed documents, wherever applicable.
5. After successful registration, candidates must retain the registration or application acknowledgement for future reference.
6. The Merit List and Waiting List shall be prepared in accordance with the applicable admission rules and the availability of vacant seats.
7. Candidates included in the Merit List or Waiting List must pay the prescribed fee within the respective deadline. Failure to pay the fee within the stipulated time shall result in cancellation of the offer of admission.
8. Admission shall remain provisional until verification of the original documents and fulfilment of all admission requirements.
9. Candidates must produce the prescribed original documents and certificates at the time of document verification.
10. If any information or document submitted by a candidate is found to be incorrect, incomplete or misleading, or if the candidate is found ineligible, the admission shall be liable to cancellation.
11. Participation in the Spot Admission Round does not guarantee admission.
12. The University shall not be responsible for any delay, technical difficulty or failure in submitting the registration form due to reasons beyond its control.
13. The schedule and number of vacant seats are subject to change. Candidates must regularly check their registered e-mail address and the official website of MNLU Nagpur for notifications and updates.
14. Students are advised to report on time and ensure that all required documents are arranged properly to facilitate smooth verification. They are also requested to remain attentive to official communications sent through email and the University website for any further updates and instructions.

15. The decision of the University regarding eligibility, preparation of merit and waiting lists, seat allotment and admission shall be final, subject to the applicable rules and regulations.

Conversion of Unfilled Category Seats

- In the event that no eligible applications are received against any reserved or designated category notified herein, the University shall, in accordance with the applicable rules, regulations, and Government Orders issued by the Government of Maharashtra from time to time, convert such unfilled seats on the day of the spot admission itself.
- Such conversion and subsequent filling of seats shall be carried out strictly as per the prevailing Maharashtra State reservation and admission norms.
- Accordingly, candidates are advised that vacant category seats, if any, may be merged/converted into other eligible categories and filled immediately during the spot admission process, without further separate notice.

Residential Campus Information:

Students are hereby informed that, for a minimum period of two years during the programme, they will reside at the University's Extended Campus/Residential Facility located at A1 Lifestyle, Dongargaon, Nagpur. The University provides pick-up and drop-off transportation between the Extended Campus and the Main Campus for academic and other University-related activities. Students residing at the Extended Campus will also be provided with mess facilities and will be entitled to some, but not all, of the campus-related facilities and services available to students residing on the Main Campus; this is due to space constraints at the Extended Campus. Students and their parents/guardians are encouraged to visit the residential facility in advance to familiarize themselves with the accommodation arrangements and the surrounding campus environment.
