INSTRUCTIONS FOR GROUP DISCUSSION

- I. The Group Discussion will be conducted as Online proctored via Zoom Online Platform;
- II. The candidates are required to download the Zoom Application on the device and Sign Up with their name and email id for Group Discussion;
- III. The Zoom Meeting Link and Time Schedule of the Group Discussion was mentioned below;
- IV. The candidate should login Ten (10) Minutes before their time slot and wait in the waiting room;
- V. Candidate will be admitted by the coordinator Five (5) Minutes before the Group Discussion session;
- VI. After the allotted starting time of Group Discussion session, the Meeting Room will be closed, late comers will not be allowed to enter and they will be marked as absent;
- VII. The entire Group Discussion sessions will be recorded;
- VIII. The Candidates should login in Zoom with their Student Id and name, candidate logging in with the names of their devices (eg. iphone12, Samsung) will be rejected/removed;
- IX. The Candidate should be in a room free of distractions and noise;
- X. The Candidate will need a webcam and microphone on their laptop/computer so the online coordinator can see and hear them during the Group Discussion sessions;
- XI. The Candidate should make sure that there is proper lighting on them and test their microphones in advance;
- XII. The Candidate should set the camera in landscape mode with their image properly centred;
- XIII. The Candidate should make sure that their desk or table top is empty and free of any papers, books, post-it notes, or writing instruments such as pens, markers, whiteboards, or pencils etc;
- XIV. The Candidate will be allowed to keep a water bottle and clear Photo Identity card;
- XV. The Candidate should ensure nobody comes in the room while they are taking the Group Discussion session; if this occurs, their Group Discussion will be terminated;
- XVI. The Candidate should sit in the same place for the entire duration of the Group Discussion session;
- XVII. The Candidate has no option to take breaks; if he/she takes a break, then his/her Group Discussion session will be terminated;
- XVIII. The Candidate with their webcam, phone or laptop may be asked to pan their full room, failing which they may not be permitted to take the Group Discussion session;
- XIX. Additional monitors must be unplugged and turned away;
- XX. Additional computers must be turned off and monitors must be dark;
- XXI. If the Candidate is found using any unfair means during the Group Discussion session will be disqualified.
- XXII. Each candidate in a group will be given 2 minutes for opening remarks and 2 minutes for closing remarks on the topic. 20 Minutes will be given for open floor discussion on the topic.

Note: Separate instructions for Psychometric Test and Personal Interview will be sent to the candidates those who are shortlisted from the Group Discussion.
