1. INTRODUCTION

The Annual Report was prepared by the Executive Council of the University regarding the working of the University in pursuance of Section 37 of the Maharashtra National Law University Act, 2014 for presentation before the General Council of the University for its consideration and approval as required by Section 14(3) of the Maharashtra National Law University Act, 2014. The period covered in this report is from April 1, 2021 to March 31, 2022.

The University commenced its academic session for the odd Semesters on June 16, 2021, for Semesters III, V, VII of B.A.LL.B.(Hons.) Five-Year Integrated Degree Course and classes for Semester-I of Undergraduate and Postgraduate Degree Courses on August 17, 2022. The End-Semester Examinations of Even Semester were conducted during April 25, 2021 to May 01, 2021 for B.A.LL.B.(Hons.) Five-Year Integrated Degree Course and during June 1-10, 2021, for B.A.LL.B.(Honours for Adjudication and Justicing) Five-Year Degree Course.

The End-Semester Examinations of Odd Semester for B.A.LL.B.(Hons.) Five-Year Integrated Degree Course were conducted during November 21-28, 2021 except for 2021-26 batch, for which it was conducted during December 18-26, 2021. The End-Semester Examinations of Odd Semester for B.A.LL.B.(Honours for Adjudication and Justicing) Five-Year Degree Course were conducted during November 21-29, 2021 and December 18-26, 2021 for second year and the first year batch, respectively.

The University opened for physical classes for Undergraduate Batch of 2017 on February 14, 2022 and for Undergraduate Batches of 2018 and 2019 on March 4, 2022.

Bar Council of India (BCI) conducted virtual inspection of the University on July 15, 2021 and renewed the approval of B.A.LL.B.(Hons.) Five-Year Integreted Degree Course and accorded fresh approval for B.A.LL.B.(Honours in Adjudication and Justicing) Five-Year Degree Course *vide* letter no. BCI: D:1146:2021 (LE/Std. 11th and 12th Sep, 21 dated September 20, 2021).

UGC Expert Committee for granting recognition under 12-B of the UGC Act 1956 visited the University for inspection during October 28-29, 2021 and the inspection report was submitted to the UGC. In its 555th meeting of the UGC held on February 12, 2022, the University Grants Commission (UGC) ratified the recommendations of Expert Committee and accorded the 12-B Status to the University. The name of the University has been included in the list of universities under Section 12(B) of the UGC Act, 1956.



6.1 Inauguration of Academic Building































The Academic Building of the Campus at Waranga was inaugurated on April 14, 2021 at the auspicious hands of Hon'ble Shri Justice Sharad A. Bobde, the then Chief Justice of India and Chancellor of the University in the physical and virtual presence of Shri Uddhav B. Thackeray, Hon'ble Chief Minister, Government of Maharashtra, Shri Nitin J. Gadkari, Hon'ble Minister of Road Transport and Highways & MSME, Government of India, Hon'ble Shri Justice Bhushan R. Gavai, Judge, Supreme Court of India, Shri Ajit A. Pawar, Hon'ble Deputy Chief Minister, Government of Maharashtra, Hon'ble Shri Justice Dipankar Datta, Chief Justice of High Court of Bombay, Dr. Nitin K. Raut, Hon'ble Minister for Energy and Guardian Minister of Nagpur District, Government of Maharashtra, Shri Uday R. Samant, Hon'ble Minister for Higher and Technical Education Department, Government of Maharashtra, Hon'ble Shri Justice Sunil B. Shukre, Administrative Judge, High Court of Bombay, Bench at Nagpur, and Shri Devendra Fadnavis, Hon'ble Leader of Opposition, Maharashtra Legislative Assembly.

6.2. Progress on Campus Development

The University through the implementing agency PWD, Government of Maharashtra made a presentation before the High-Powered Committee (HPC) Chaired by Shri Sitaram Kunte, IAS, Chief Secretary, Government of Maharashtra for an additional Administrative Approval for an amount of Rs.170.12/- Crores. The Higher and Technical Education Department, Government of Maharashtra communicated to the University *vide* Letter No. NLUN-2021/Pra.Kra.06/Vishi-2 dated May 06, 2021, that the High-Powered Committee (HPC) approved an amount of Rs.95,15,97,211/- (Rupees Ninety-Five Crores Fifteen Lakhs Ninety-Seven Thousand Two Hundred and Eleven Only) without any financial support.

The University sent a communication to the District Collector, Nagpur on February 5, 2021, for allocation of funds amounting to Rs.29.29/- Crores under District Planning Committee (DPC) Programme. Against the said communication the University received an Administrative Approval *vide* Letter bearing No. ZiNiS/ZiYYo/Ka-6/610/2021-22 dated April 26, 2021, for an amount of Rs.24.76/- Crores from the Office of District Collector, Nagpur.

As per Resolution of the Executive Council, the University applied to the State Bank of India, Industrial Finance Branch, Bharat Nagar, Nagpur for a Term Loan of Rs.50/- Crores on June 10, 2021. The necessary formalities for the loan were completed and as per the conditions of the Term Loan the University mortgaged the buildings and hypothecated the assets. The loan

amount was sanctioned on August 26, 2021 with Interest Rate of 9.65% per annum. For processing the loan, the University has to spent Rs.87,32,910/- (Rupees Eighty-Seven Lakhs Thirty-Two Thousand Nine Hundred and Ten Only). The loan amount was disbursed to the University on September 22, 2021. After getting the due approval from Hon'ble Shri Justice Anil S. Kilor, Judge, High Court of Bombay and Chairman of the Building Committee an amount of Rs.40/- Crores was transferred to Public Works Department, Division-I, Nagpur on September 29, 2021, and Rs.10/- Crores on November 29, 2021.

The Government of Maharashtra after taking into consideration the request made by the University revised the existing Government Resolution and accorded financial approval for an amount of Rs.95.15/-Crores *vide* Government Resolution No. NLUN-2021/Pra.Kra.06/Vishi-2 dated December 17, 2021. Against this resolution the University has received Rs.8/- Crores *vide* Government Resolution NLUN-2021/Pra.Kra.06/Vishi-2 dated January 7, 2022, Rs.18 Crores *vide* Government Resolution NLUN-2021/Pra.Kra.06/Vishi-2 dated February 11, 2022 and Rs.12/- Crores *vide* Government Resolution NLUN-2021/Pra.Kra.06/Vishi-2 dated March 22, 2022.

7.2 B.A.LL.B.(Honours in Adjudication and Justicing) Five-Year Degree Course

The University issued Admission Notification to this programme on July 28, 2021. The Online application form for the said programme opened on August 2, 2021 and the Last Date of application was August 31, 2021, and 342 applications were received till 11:59 p.m. on August 31, 2021 which was the last date for receipt of applications. Admissions to this Course have been done through CLAT-2021 based first stage shortlisting followed by a Group Discussion conducted Online on September 4-5, 2021, and Psychometric Test conducted Online on September 13, 2021, and Personal Interviews conducted Online on September 18-19, 2021.

SHL India Pvt. Ltd., a company experienced in conducting Psychometric Tests, was hired for the said test. Group Discussions were conducted by two panels with one member from the University in each panel, while Dr. Jigna Trivedi, Associate Professor, Shri Jairambhai Patel Institute of Business Management and Computer Applications, Gandhinagar, Gujarat, Dr. D. Barani Ganth, Associate Professor of Psychology, Pondicherry Central University, Pondicherry, Dr.

9. UNIVERSITY ACTIVITIES

9.1 Common Law Admission Test (CLAT)- 2021

The Vice-Chancellor Prof. (Dr.) Vijender Kumar was elected as the Convenor for CLAT 2021 and the test was hosted by MNLU Nagpur. Under his leadership, CLAT-2021 was conducted smoothly in pen and paper mode on July 23, 2021 between 02:00 pm to 04:00 pm for Undergraduate and Postgraduate Programmes. CLAT-2021 was conducted with 24 Regional Centres coordinating 147 Centres spread across 82 cities of India. A total of 70,277 candidates registered for Undergraduate and Postgraduate programmes on online portal of which 66,887 downloaded their Admit Cards from July 14, 2021 onwards while 62,106 appeared for the test.

To ensure fair and smooth conduct of the test, division of 24 regions was made and Regional Coordinators (Vice-Chancellors of the NLUs/ Universities) were entrusted with the respective regions. The Registrars of the respective NLUs/ Universities were entrusted with the responsibility of coordinating among the CLAT -2021 Convenor Office, Regional Coordinators and the Test Centres. The Office of the Convenor, CLAT-2021 conducted Online interaction with all Centre Observers and Centre Superintendents on July 20, 2021.

Local Administration of States where there were serious concerns of Pandemic were taken into confidence and CLAT-2021 Convenor Office liaisoned with the Government Offices from time to time.

In its meeting held on July 28, 2021, the Executive Committee of Consortium of NLUs approved the CLAT-2021 Result of UG and PG Programmes and recommended it to the General Body for its approval. The General Body of Consortium of NLUs in its meeting held on the same day approved the result unanimously for both UG and PG and recommended it to be published. Accordingly, the result was published on the website of the Consortium on July 28, 2021.

Counselling invite list was published on July 29, 2021 and candidates were invited to participate in Counselling Registration from July 29, 2021 to July 30, 2021. The First Allotment list was published on August 1, 2021 on CLAT website containing indicative allotment to various NLUs based on merit cum preference of the candidates and candidates were given time from August 1, 2021 to August 05, 2021. Five Allotment lists were released based on the data of vacant seats provided by respective NLUs. Fifth and final Allotment list was published on August 20, 2021. As the centralized admission closed on August 21, 2021, the NLUs were notified to continue to fill the vacant seats independently while using CLAT-2021 merit.

The Convenor Office notified the closure of centralized admission process on August 23, 2021.

9.3.1 Two-Day International Seminar on 'Access and Benefit Sharing: Sustaining Indian Biodiversity'

The Centre for Environmental Law in collaboration with Maharashtra State Biodiversity Board, Nagpur organized a Two-Day International Seminar on 'Access and Benefit Sharing: Sustaining Indian Biodiversity' on November 12-13, 2021. The brochure of the event was shared on many online platforms like Lawctopus, Live Law, etc. The authors were asked to mandatorily register for the seminar after communication of acceptance of their abstract. The registration window was opened on October 15, 2021 and stayed active for more than a month i.e., until November 10, 2021. Fifty-five abstracts were received and 30 authors registered themselves for the presentation of papers in the Webinar. On the first day, the event began with the Inaugural Ceremony followed by five parallel technical sessions. Each technical session had two technical experts, multiple presenters, three rapporteurs and a moderator. After the conclusion of each technical session, report was prepared by rapporteurs summarizing the findings of that session and the same was placed before the organizing team for further deliberations. Round table session was conducted on November 13, 2021. It was divided into five broad themes. Each theme had 2-3 guest speakers who shared their thoughts on the theme and at the end of each theme, there was an open dialogue among the experts followed by a brief question/answer session. After the conclusion of the round table session, Valedictory Ceremony was organized on November 13, 2021. This ceremony was graced by the presence of NBA Chairman, Shri V.B. Mathur and Senior Advocate Sriram Panchu.

9.7 Mental Health and Wellness



Objectives:

- → To ensure that students are taking care of their mental health and emotional wellbeing.
- → To undertake initiatives physical and virtual in an attempt to educate and raise awareness regarding the significance of mental health.
- → To facilitate smooth transition of students from virtual to physical mode by ensuring accessibility.

Mission:

To create an environment that helps destignatise and unlearn pre-conceived notions around mental health amongst students of the University.

To meet the above-mentioned objectives set out during the virtual and later hybrid mode commencing from March, 2022 in an attempt to increase the accessibility of help with respect to mental health, the following activities were undertaken to ensure upkeep of mental health and morale. The main purpose of the various initiatives undertaken was to creating a conducive environment for connecting and engaging with students to tackle various challenges posed by the COVID-19 pandemic and allied aspects of concerns.

Various studies undertaken in an attempt to statistically understand the scale of impact that the pandemic has imposed on individuals have deduced that it has roughly doubled the risk of mental health symptoms and loneliness.

Areas of help covered through virtual platforms and physical mode of counselling (Mental Health Camp and Hostel Counselling) include but are not limited to:

- Anxiety
- Depressive episodes
- Adjusting with parents, travel restrictions, physical mode of education.
- Suicidal Ideation
- Adjustment to online mode of learning.
- Loneliness

Induction of Volunteers and Group Leaders

For effective communication of the activities undertaken by the Mental Health Army as well as acting as point of contact, Group Leaders and Volunteers were inducted considering their skill set, interests and willingness to learn and contribute to the operations.

Since the Founding Members and subsequent team leads deemed it appropriate to transfer their responsibilities to the upcoming batches of Maharashtra National Law University, Nagpur, the Group Leaders were mentored by them and guided by the University Counsellor.






